# What the "One Big Beautiful Bill Act" (H.R. 1) Means for the Hispanic Community

## Signed into law July 4, 2025, by President Trump

## **Major Impacts:**

#### **Healthcare Cuts**

- 16 million Americans projected to lose insurance<sup>5, 6, 7, 11</sup>
- Deep Medicaid cuts heavily affect Hispanic families and children<sup>5,6,7,11</sup>
- Cutting Medicaid could lead to the potential closures of hospitals and clinics in rural and underserved communities<sup>5, 6, 7, 10, 11</sup>
- Medicaid cuts totaling \$911 billion, which affect 6 in 10 nursing home residents<sup>5,11</sup>
- Free primary care clinics will be unable to meet this high demand<sup>5, 6, 7, 11</sup>
- Rising nurse burnout and attrition due to overburdened systems<sup>10, 11</sup>
- Effects on patient outcomes 10, 11

#### **SNAP / Food Assistance**

- \$186 billion cut from SNAP (food stamps) over 10 years<sup>1,2</sup>
- Hurts families, grocery workers, truck drivers, and farmworkers<sup>1,2</sup>
- Increases food insecurity and weakens local economies<sup>1,2</sup>

#### **Immigration & Deportations**

- ICE will receive \$100 billion by 2029<sup>2, 3, 4</sup>
- Enables up to 1 million deportations per year<sup>2, 3, 4</sup>
- Targets mixed-status families, increases detention, trauma, and fear<sup>2, 3, 4</sup>

#### **Tax & Energy Changes**

- Increasing annual energy bills across American households<sup>8</sup>
- Cuts or repeals green energy tax credits (EVs, home upgrades)<sup>1,8</sup>
- Expands some fossil fuel tax breaks<sup>1, 8</sup>
- Extends Trump-era 2017 tax cuts biggest gains go to the wealthy & corporations<sup>5, 6, 8</sup>
- Projected decrease in the U.S. workforce by 840,000 jobs in 2030 and another 790,000 in 2035<sup>5,68</sup>

## **Bottom Line:**

### This bill may benefit large corporations, but will hurt many Hispanic communities through:

- Reduced access to health care<sup>2,3,4,9</sup>
- Higher food insecurity<sup>2,3,4,9</sup>

- Greater immigration enforcement<sup>2,3,4,9</sup>
- Fewer energy & economic opportunities<sup>2,3,4,9</sup>

## What You Can Do:

- **Stay Informed**: Know the facts about H.R. 1
- Vote in all elections—local & national
- Contact Your Representatives: Tell them how this affects your family
- **Join Local Organizations:** Those that are working on healthcare, immigration & food justice
